

PARENT PAYMENT ARRANGEMENTS

Key points:

2025 Contributions open 16/12/24 on Compass and 28/01/25 in person

Parents can change the amount to pay in Compass – either higher or lower as these are voluntary contributions that go toward **all basic curriculum resources** in the school.

Parents can pay over the phone with a credit card – Mastercard or Visa from the beginning of the 2025 school year.

Donations to the library fund and building fund are tax deductible and a tax receipt will be issued and sent home with your child.

Donations can also be made to the school for general purposes at any time of the year (not tax deductible) over the phone or in person.

2025 Payments options – no contributions can be made until Monday 16th December – we need to finalise 2024 events and activities before we begin collecting for 2025.

Payment methods

McKPS welcome any contributions to support our school. Payments can be made through the Parent Portal on Compass or over the phone with visa or mastercard. We do not accept cash payments. Payments can be made on Compass from Monday 16th December 2024 or over the phone once school commences in 2025.

We would appreciate contributions being received by 31st January 2025 to help with our planning and resource allocation. However, we are also offering a payment plan that will finish 21st February 2025.

Your child will not be disadvantaged if you do not make a voluntary contribution. All records of voluntary contributions are kept confidential as well as your decision about whether you wish to contribute or not.

Refunds

Parent requests for refunds are subject to the discretion of the school and made on a case-by-case basis. Refunds will be provided where the school deems it is reasonable and fair to do so, taking into consideration whether a cost has been incurred, the Department's Parent Payments Policy and Guidance, Financial Help for Families Policy, and any other relevant information. FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
